2. against all such claims and other actions by any person including any person claiming an interest as owner, partner, share farmer, mortgagee or otherwise whether in the land of the transferor and/or transferee or the crop of produce there from or in respect of any other matter howsoever arising
  - a. in respect of the registration or failure to register any bid or offer to sell or purchase temporary water on the exchange
  - b. the sale or failure to sell any water at any particular price, and
  - c. any other matter, act, thing or circumstance relating directly or indirectly to the operation of the exchange.
